On Wednesday, May 25, year two thousand and twenty-two (25-05-2022) in Ambon, the undersigned:

Dr. Merry Pattipeilohy., M.Pd : The Head of the Study Program of Biology Education, Faculty of Teacher's Training and Education Science in this case acting for and on behalf of The Study Program of Biology Education, Faculty Teacher's Training and Education Science, Pattimura University, which is domiciled on Jl. Ir. M. Putuhena Poka-Ambon Campus, Ambon Bay, Ambon, Maluku 97233, hereinafter referred to as the SECOND PARTY;

(Ketua Program Studi Pendidikan Biologi, Fakultas Keguruan dan Ilmu Pendidikan dalam hal ini bertindak untuk dan atas nama Program Studi Pendidikan Biologi, Fakultas Keguruan dan Ilmu Pendidikan, Universitas Pattimura, yang berkedudukan di Jl. Ir. M. Putuhena Kampus Poka-Ambon, Teluk Ambon, Ambon, Maluku 97233, yang selanjutnya disebut sebagai PIHAK KEDUA;)

Based on the above matters, the PARTIES (FIRST PARTY AND SECOND PARTY) agreed to make an Implementation Arrangement (hereinafter referred to as Implementation Arrangements) based on the Memorandum of Understanding Number: 74/UN13/LN/2022, with the following provisions.

The Parties (First Party and Second Party shall be carried out through any one or more of the following activities or programs as mutually agreed to by the parties:


- Implementation of cooperation in the field of Education:

- ✓ Carry out activities in the form of seminars on plastic waste pollution in the waters
- ✓ Organizing guest lectures on plastic waste, its dangers and prevention
- ✓ Develop module or curriculum about plastic pollution that can implemented in elementary school and junior high school based on local condition and wisdom
- ✓ Conducting workshops that involve students and teachers in advancing and improving project implementation
- **Implementation of Cooperation in the field of awareness:**
 - ✓ Jointly run an awareness program for the general public, elementary and middle school students, and university students
 - ✓ To jointly develop a communication strategy for community outreach including primary and secondary school students, university students and the general public.
- **Implementasi kerjasama di bidang Pendidikan:**
 - ✓ Menyelenggarakan kegiatan seminar-seminar tentang polusi sampah plastic Diperairan
 - ✓ Mengorganisir kuliah tamu tentang sampah plastic, bahaya dan penanggulangannya
 - ✓ Mengembangkan modul dan kurikulum tentang polusi sampah plastic yang dapat diterapkan di sekolah dasar dan menengah berdasarkan kondisi dan kearifan lokal
 - ✓ Melaksanakan lokakarya yang melibatkan mahasiswa dan pengajar dalam memajukan dan perbaikan implementasi project
- **Implementasi Kerjasama di bidang penyadartahuan:**
 - ✓ Bersama-sama menjalankan program penyadartahuan kepada masyarakat umum, siswa sekolah dasar dan menengah, serta mahasiswa
 - ✓ Menyusun bersama-sama strategi komunikasi untuk penjangkauan masyarakat termasuk kepada siswa sekolah dasar dan menengah, mahasiswa dan masyarakat pada umumnya.
