Dr. Prapti Murwani, M.Si : The Head of the Study Program of Sociology, Faculty of Social and Political Sciences in this case acting for and on behalf of the Study Program of Sociology, Faculty of Social and Political Sciences, Pattimura University, which is domiciled on Jl. Ir. M. Putuhena Poka-Ambon Campus, Ambon Bay, Ambon, Maluku 97233, hereinafter referred to as the SECOND PARTY;

(Ketua Program Studi Sosiologi, Fakultas Ilmu Sosial dan Ilmu Politik, Universitas Pattimura dalam hal ini bertindak untuk dan atas nama Program Studi Sosiologi, Fakultas Ilmu Sosial dan Ilmu Politik, Universitas Pattimura, yang berkedudukan di Jl. Based on the above matters, the PARTIES (FIRST PARTY AND SECOND PARTY) agreed to make an Implementation Arrangement (hereinafter referred to as Implementation Arrangements) based on the Memorandum of Understanding between the PARTIES with the following provisions.

The Parties (First Party and Second Party) are carrying out through any one or more of the following activities or programs as mutually agreed to by the parties:


- Organizing guest lectures on the issues of sociology and anthropology;
- Organizing the students' examiners;
- Conducting joint research and that involves students and lecturers.
- Exchange and transfer knowledge with junior teachers
- Supervision of Potential PhD students in writing proposal

- Mengorganisir penguji mahasiswa dalam seminar dan ujian
- Melaksanakan penelitian bersama yang melibatkan mahasiswa dan dosen

- Melakukan pembimbingan kepada calon mahasiswa PhD dalam penulisan proposal.

This agreement is made and signed by the PARTIES in 2 (two) original copies, with sufficient stamp duty for each PARTIES.


