- 3 This MOU may only be amended or modified by a written agreement signed by the representatives of each Party
- 4. It is understood that this agreement will be implemented by the participating institutions. The MOU shall be effect from the date of its signing and be valid for the duration of five years from that date and will be automatically renewed on an annual basis. This MOU may be terminated by either party by written notice at least six months in advance.
