KOREA NATIONAL COOPERATIVE ASSOCIATION with PATTIMURA UNIVERSITY (hereinafter referred to as “Each Party”) is in recognition of the need for close work support between each institution. We have concluded an institutional cooperation agreement as follows.

Article 1 [Purpose] The purpose of this Convention is to promote mutual support and development between the two organizations by establishing an organic cooperative system between each party under the principle of mutual trust.

Article 2 [Basic Principles] Each institution shall, in principle, comply with the regulations of the other institution in mutual cooperation.

Article 3 [Contents of the Convention] In order to achieve the objectives of Article 1, each institution shall use its capabilities and resources to cooperate with each other in each of the following matters:

- Cooperate with the business support for fisheries fishing
- Provision of information related to service linkage related to trade, such as fishery products
- Provision of information on aquatic products storage, etc. and cooperation
- Mutual cooperation on the establishment of aquaculture farms
- Mutual cooperation on import and export of seafood
- Various solidarity activities for human exchange and mutual development between institutions
- Cooperation to support other mutual needs
- Requests for cooperation between the two countries on the cooperation of institutions and institutions.
- Maximal cooperation for the common interests of institutions and institutions.

- Provision of maximum convenience for human exchanges of institutions and institutions.

Article 4 **【Term of Agreement】** This Agreement is effective from the date of signature by the representatives of both organizations, and the validity period is 2 years, and unless there is an objection between the parties, it is automatically extended by 1 year.

Article 5 **【Good faith】** Each party shall faithfully implement the matters necessary for the implementation of this Agreement in accordance with the principle of good faith and make an active effort to implement the matters stipulated in Article 3.

Article 6 **【Conciliation of Agreement】** If there is any objection to the interpretation of this Agreement or if there is a matter to be discussed, it shall be arbitrated or decided through mutual consultation between the parties.

Article 7 **【Confidentiality】** Each party shall not disclose or use the other party's confidential information, personal information and business information acquired in the course of activities under this Agreement for any other purpose without the consent of the other party.

Article 8 **【Enforcement Rules】** If necessary, each institution may separately set the enforcement rules for this Convention through consultation.

Article 9 **【Others】** Each party shall not be held jointly liable for a third party of either party, and if a dispute arises in relation to this cooperation, the resolution by consultation between the parties shall prevail.

Matters not specified in this agreement are decided by mutual consultation between the parties, and each institution keeps one copy after signing or signing the agreement to faithfully implement the contents of this agreement and certify the agreement.
