 - b. Exchange of students for study and research
 - c. Exchange of faculty for instruction, research and lectures
 - d. Exchange of educational materials, research projects and publications
 - e. Joint conferences, seminars and workshops
 - f. Cooperation with both Korean language centers
2. The development and implementation of specific activities based on this MOU will be separately negotiated and agreed between institutes which carry out the specific projects and will be subject to a separate written agreement.
3. This MOU may only be amended or modified by a written agreement signed by the representatives of each Party.
4. It is understood that this agreement will be implemented by the participating institutions. The MOU shall be effect from the date of its signing and be valid for the duration of five years from that date and will be automatically renewed on an annual basis. This MOU may be terminated by either party by written notice at least six months in advance.
