

## MORANDUM OF UNDERSTANDING **BETWEEN** UNIVERSITAS PATTIMURA-INDONESIA AND SHINHAN UNIVERSITY - REPUBIC OF KOREA



Universitas Pattimura, Indonesia and Shinhan University, Republic of Korea agree to cooperate on international programs based on the principle of reciprocity.

This Memorandum of Understanding (MOU) encourages the cooperation on international program and materials in the belief that the research and educational processes at both institutions will be enhanced.

- 1. The both institutions agree to promote the following exchange activities based on their respective academic and educational needs:
  - a. Exchange of students and faculty members
  - b. Exchange of academic information and materials
  - c. Organization of joint education programs
  - d. Organization of joint international program
  - Other academic exchanges agreed to by both institutions
- 2. The implementation of each specific exchange based on this MOU shall be separately negotiated and determined by both institutions. Efforts shall be made by both sides to find financial sources for carrying out the exchange programs.
- 3. Nothing shall diminish the full autonomy of either institution, nor will any constraints or financial obligations be imposed by either upon the other in carrying out the MOU.
- 4. This MOU is in force for five years and is subject to revision or modification by mutual agreement. It is also understood that either institution may terminate the MOU at any time, although such action will only be taken after mutual consultation in order to avoid any possible inconvenience to all parties. This MOU shall take effect from the date of the latest signature below.
